Club will be responsible for fixing the lights at Resoft Park. Club will get an engineer out to park to look at lights and give an estimate. We will present the estimate to STYSA for funding of project.

County has given club permission for expansion of the concession area. Don made a motion to pursue the project, Margaret 2<sup>nd</sup>. Motion passed.

County will take meter from club. Club will pay county for lights.

STYSA Winter Meeting will be held in July in Houston.

Infinity will NO LONGER be available after spring season.

**NEW BUSINESS:** Club needs to recruit referees. Ref rates went up to \$20-25 per game. All referee training classes need to be taken before end of May or they cannot ref games until 2010. BAYSA will reimburse for youth refs uniforms.

Host of playoffs need to be turned in to Randy at BAYSA no later than June 1, 2009. 3v3 Tournament has been approved by BAYSA and information is on club website. Concessions for 3v3 will be snow cones, pickles, sodas, chips and CICI pizza.

Open Registration for Adult tournament to benefit St. Jude's Children's Hospital. Shala made motion to approve, Margaret 2<sup>nd</sup>.

Adult team will be \$150 registration. Late reg. fee will be \$175.

Each board member was issued an expense folder. They will keep track of any and all club related expenses. Will bring folder to each meeting to be reimbursed if needed.
