Shauna made a motion to accept the minutes from January's meeting. Sara seconded the motion and motion was passed.

Officer's Reports:

Old Business:

New Business:

Tara has been assigned to handle the rekeying of the locks for the container, concession stand, and lights and to obtain 10 keys for each location.

Information from Shala that a deposit of \$500.00 is needed for the concession stand at Brisco Park is required to take care of any damage to the building. This topic was tabled until the next meeting for further discussion.

Raffle – fundraiser: we will sell tickets for \$1.00 per ticket. Gift cards will be purchased from Wal-Mart in the amounts of \$500, \$300, and \$200. Each player is required to sell 50 tickets but a maximum of 100 tickets for those who have more than two children in an immediate family registered with AYSC.
