Dates:	February 27 – April 17 (U5-U12); March 27 – May 7 (U13 and up). No games on spring break weekends (March 12-13 and 19-20) or Easter (April 23-24)
Teams Due	Teams are due in Affinity by February 12, 2011
Registration Due	Registration ends April 1, 2011
Guest Players	No more than two guest players; must be BAYSA registered players
Format	U9/10 – 6 aside on normal field U11/12 – 8 aside on normal field U13 up – 11v11 on normal field Teams will remain at same age and play level as designated in the fall 2010
Team Fees (fees are based on a 6-game season)	U5-U8 – no fee, in house U9-U10 - \$69/team U11-U12 - \$177/team U13 –U14 - \$222/team U15-U16 - \$273/team U17-U19 - \$303/team
New Player Fees	U5-10 = \$16; U11 and older = \$30
